This Addendum forms part of the Contract Documents and modifies the original specifications and drawings dated April 2017. Acknowledge receipt of this Addendum in the space provided on the Bid Form. Failure to do so may subject the bidder to disqualification.

The following changes and/or additions are to be made to the Contract Documents:

Specifications

Section 00031 – Advertisement for Bids

a. Paragraph 1 delete paragraph and replace with the following:

"Sealed bids for Water System Improvements-Phase 3, shall be received by the Hamilton Department of Public Works, at their offices 577 Bay Road, P.O. Box 429, Hamilton, MA 01936, until 2:00 PM Local Time, Thursday, May 25, 2017 and at that time and place shall be opened and read aloud publicly."

2. Section 00101 – Information for Bidders

1. General delete paragraph and replace with the following:

"1. GENERAL

Bids will be received by the Hamilton Department of Public Works, herein called the "OWNER", at their offices 577 Bay Road, P.O. Box 429, Hamilton, MA 01936, until 2:00 PM Local Time, Thursday, May 25, 2017, and then at said office publicly opened and read aloud.

Each Bid must be submitted in a sealed envelope, addressed to Hamilton Department of Public Works, Hamilton, Massachusetts. Each sealed envelope containing a Bid must be plainly marked on the outside as **Bid for Water System Improvements-Phase 3** and the envelope should bear on the outside, the name of the BIDDER, his address, his license number, if applicable, and the name of the project for which the Bid is submitted. If forwarded by mail, the sealed envelope containing the Bid must be enclosed in another envelope addressed to the Hamilton Department of Public Works, 577 Bay Road, P.O. Box 429, Hamilton, MA 01936.

All Bids must be made on the required Bid form. All blank spaces for Bid prices must be filled in, in ink or typewritten and the Bid form must be fully completed and executed when

submitted. Only one copy of the Bid form is required. The bid form must not be detached from the contract documents.

The OWNER may waive any informalities or minor defects or reject any and all Bids. Any Bid may be withdrawn prior to the above scheduled time for the opening of Bids or authorized postponement thereof. Any Bid received after the time and date specified shall not be considered. No BIDDER may withdraw a Bid within 30 days, Saturdays, Sundays, and Holidays excluded, after the actual date of the opening thereof. Should there be reasons why the Contract cannot be awarded within the specified period, the time may be extended by mutual agreement between the OWNER and the BIDDER."
