Sample case histories

In creating **Seeding Labs**, the founder distributed surplus laboratory equipment and other resources to equip scientists with the tools, training, and connections they needed to be on the cutting edge of global discovery. With a relationship since Seeding Labs' inception, ESC helped create a business plan, craft a funding proposal for explosive growth, and hire more people. The result? Staff has grown by 900%, revenue by 578%, and the number of clients served by 1,000%.

BAMSI, a rapidly growing statewide human services organization, provides over three dozen programs and supports over 25,000 individuals and their families with developmental disabilities, traumatic brain injuries, and behavioral health challenges. Over the past three years, BAMSI's leadership has engaged a team of ESC consultants to provide guidance and support on a broad range of issues including organizational development, board effectiveness, strategic planning, and branding.

Talking Information Center (TIC), which provides news and information to visually impaired and disabled listeners, faced budget cuts and a major transition to a new government agency.
