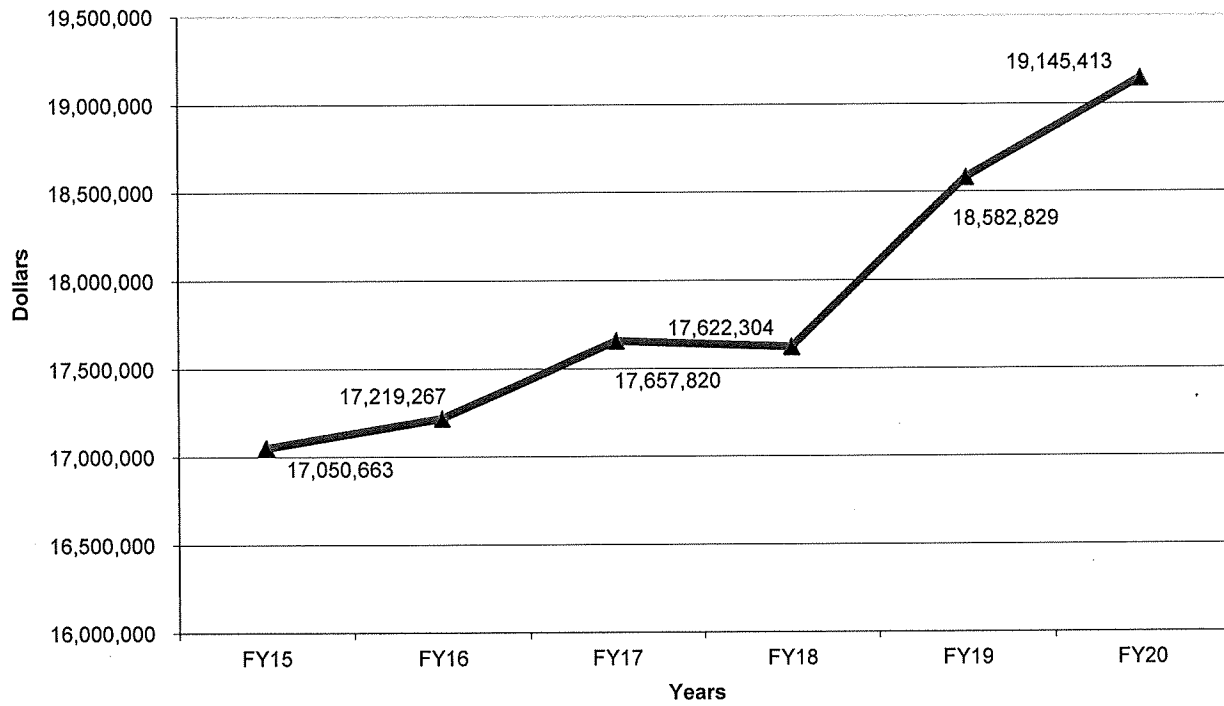

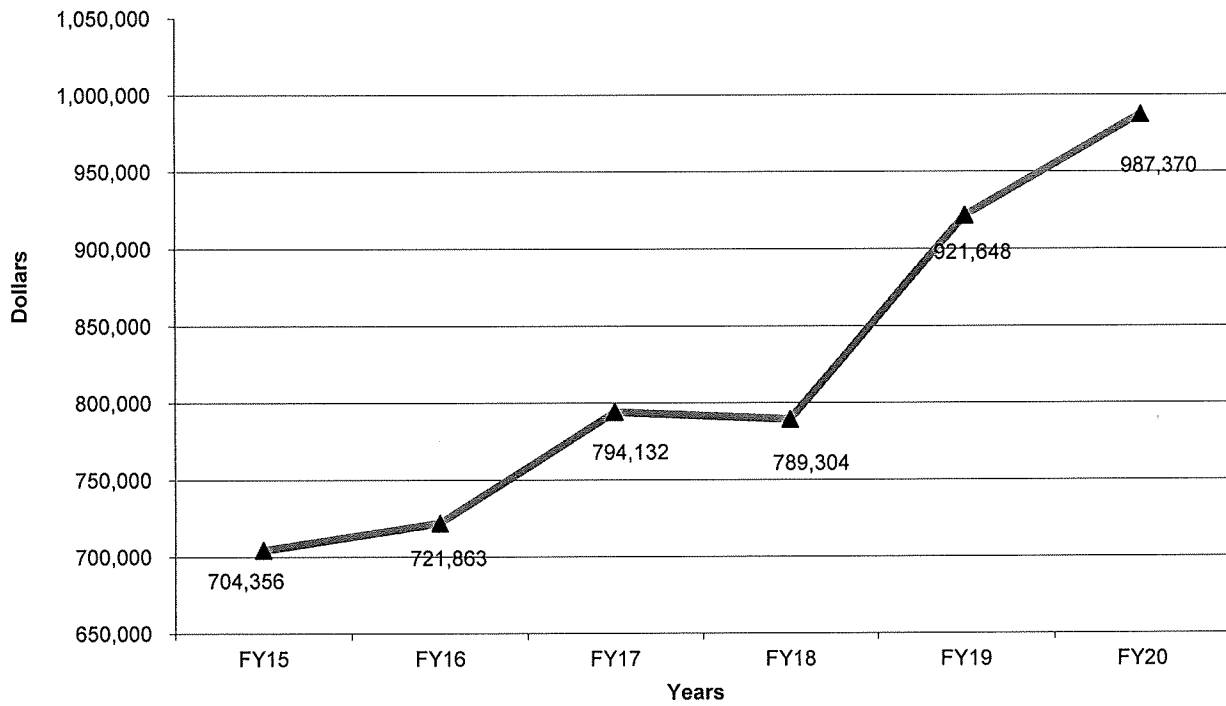
**Education Costs**

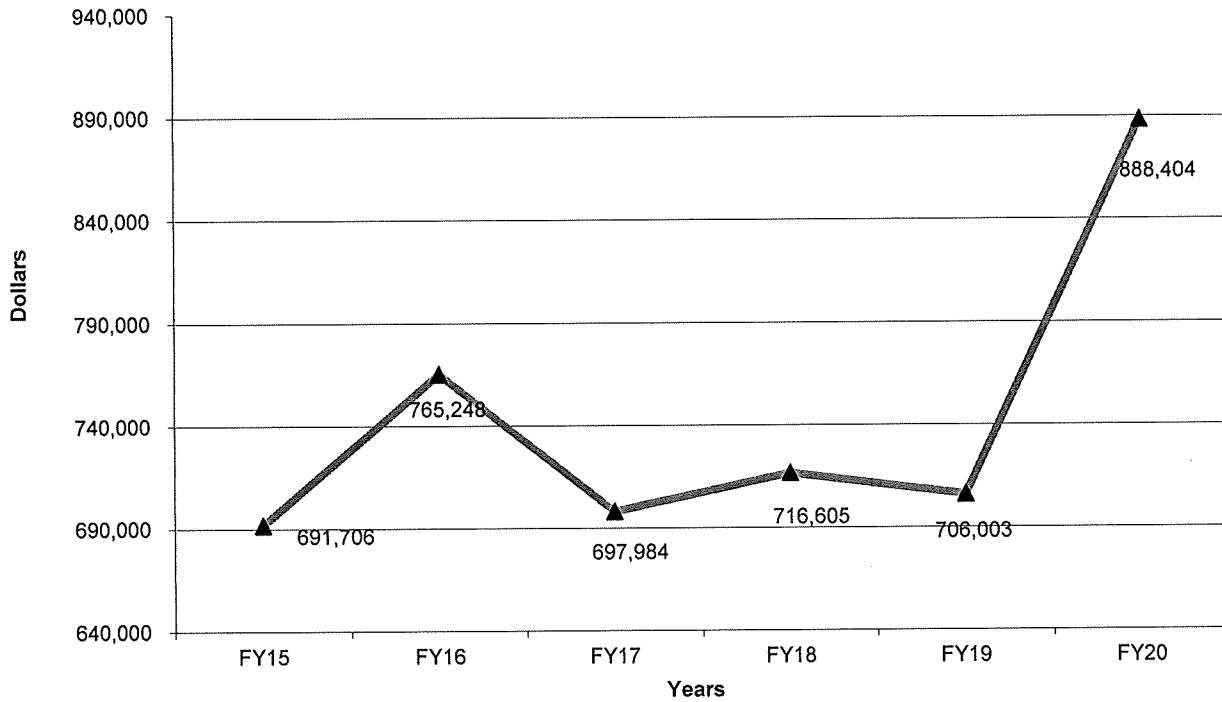
**Retirement Costs**
