- Proposed Amendment to the Hamilton Zoning By-Law The Hamilton Planning Board held a public hearing on August 7, 2018 seeking to modify the existing Hamilton Zoning By-Law with newly proposed language addressing Accessory Apartments. The hearing was closed after text modifications were discussed, verbally agreed upon and will be voted upon at this or an upcoming Planning Board meeting.
- 2. Mobilitie LLC, Newport Beach, CA Wireless/ Cellular Communication Pre-Application New Utility Pole nearest 181 MA near 169 Bay Road (State Route 1A) Mobilitie representatives will informally present a preliminary wireless cellular communication equipment application to the Planning Board. The specific location will be upon a utility pole which is within the Business (B) zoning district. A formal Special Permit application and process will take place at a later date after appreciate submittals have been submitted by Mobilitie.
- 3. <u>Informal Discussion re Subdivision Discussion</u> The Board will host an informal discussion with property owner Tom Ford, and possibly others regarding parcels at 601, 605, 609 and 613 Bay Road.
