DOG LICENSES DUE APRIL 1st – LICENSE FEES:

NEUTERED AND SPAYED - \$15.00

NOT NEUTERED OR SPAYED - \$20.00

All dogs 6 months of age must be registered annually in the towns in which they reside per Massachusetts General Law Chapter 140, Sec. 137. Registration may be done online at www.hamiltonma.gov on the homepage under the 'Pay Bills' button or by mailing your application to the Clerk's Office. Rabies Certificate must accompany application and will be returned to you upon our mailing you thelicense and tag. Due to the pandemic, we discourage walk-in service and recommend that dog owners mail or go online to renew or register their dog(s).
