- <u>ANR / APPROVAL NOT REQUIRED REQUEST.</u> In accordance with MGL Ch. 41, Sec 81 the applicant Gelean M. Campbell, 10 Paige Farm Road, Amesbury, MA, represented by Kirsten R. Griebel, (192 Linden St., Hamilton, MA) is seeking a Form A / Approval Not Required (ANR) endorsement from the Planning Board to allow a land transfer of 6,586 square feet from 11 Naples Rd. (Assessors Map 55, Lot 58) to 192 Linden St. (Assessors Map 55, Lot 57). The transfer allows 192 Linden to be conforming to area requirements within the R-1A Zoning District.
